We collect and use personal information about you so that we can provide you with a policy that suits your insurance needs. Additional controllers include the Administrator, Aon UK Limited and The Wrekin Housing Group, who are responsible for the sale and distribution of the product, and any applicable insurers, reinsurers or brokers we use.

#### Personal information we collect and how we use it

We will use personal information collected from you and obtained from other sources:

- to provide you with insurance: we need this to decide if we can offer insurance to you and if so on what terms and also to administer your policy, handle any claims and manage any renewal,
- to support legitimate interests that we have as a business. We need this to:
- manage arrangements we have with our insurers, reinsurers and brokers we use, and for the detection and prevention of fraud
- help us better understand our customers and improve our customer engagement. This includes
